Q. OSHA Notebook- 5 years or less.

A. Spore test notebook? You keep that for 5 years. OSHA manual? Must be personalized and companies only sell you a manual as a guideline, but you may wind up answering the questions. Incorrectly. If you don't have one, we can help you write a manual thru - teleconference.

Q: SDS Sheets:

A. Sheets should now be in binder. Make sure your reps are sending any new or sheets that have changed through snail mail. It's their responsibility. It's a federal guideline!

Q: Chemical Inventory List

A: This list is kept for 30 years and goes in your Hazard Communication Manual. This is a list of all hazards in your office. Request that your sales rep to send you your history through the email. Then copy paste the hazards onto an Excel sheet or Word
